# WHAT IS HLS?



Huntingdon Life Sciences (HLS) is one of the world's largest animal testing labs. It operates two facilities in England and one in East Millstone, NJ. Animals are forced to inhale, ingest, and endure exposure to excessive amounts of products such as weed killers, pesticides, tanning lotions, diet pills, and genetically modified organisms (GMO's) for weeks or months on end. Then they are killed and dissected. Every day on average 500 animals, including dogs, cats, mice, primates, and rabbits, die inside HLS.

HLS has been exposed in five undercover investigations revealing vicious animal cruelty and sloppy, fraudulent science. Among other atrocities, workers were exposed punching 4-month-old beagle puppies in the face, dissecting a conscious monkey, falsifying scientific data, and violating Good Laboratory Practicice laws over 600 times.

WHAT IS HLS?

Many M.D.s and scientists are speaking out against animal research as an outdated and dangerous form of pseudo-science. They argue that enormous physiological variations exist between species, making it impossible to extrapolate experimental results from one species (i.e. a rat or monkey) to another (i.e. humans). Animal studies are not only cruel and waste limited research grant monies, but also harm and kill people. One in 7 people are in the hospital today as a result of an adverse reaction to prescription drugs - which have been put on the market after

being found "safe" in animal tests - and it is the fourth leading cause of death in the U.S.

HLS researchers themselves have been caught by investigators stating that their animal research is "only reliable 5-25% of the time." What about the other 75-95% of the time? When a worker was questioned as to whether an experimental procedure was done correctly he replied, "Nope. Not supposed to, never saw it, never did it, can't prove it." Vivisection in its truest form.

# WHO IS SHAC?

Stop Huntingdon Animal Cruelty (SHAC) is an internationally-active campaign to close HLS. By targeting the company's pillars of support - investors, stockbrokers, suppliers, and management infrastructure - the efforts of thousands across the globe have brought HLS to its knees. From the world's most significant financial institutions - among them Citibank, Merrill Lynch, and Charles Schwab - to those who facilitate daily business at HLS - including its janitorial company and food service - companies are fleeing HLS like a sinking ship.

SHAC is an all-volunteer, full time effort that has revolutionized the animal rights movement, demonstrating that the grassroots can organize an effective, self-sustaining campaign and topple even the most powerful opposition.

Since the inception of the SHAC campaign in November 1999, HLS has gone through two refinancings, been forced off the London Stock Exchange and the New York Stock Exchange, and watched its share price fall from a one time high of \$30 to an all time low of 1/1000th of a cent. Additionally the lab has fallen more than \$80 million into debt trying to keep itself afloat.

Meanwhile SHAC has gone global with campaign activity in 18 countries and nearly every major city across the U.S., and is gaining momentum every day with new ideas, new targets and new ways to close HLS once and for all!
